w/ Electricity—September 3<sup>rd</sup> & September 4<sup>th</sup>—5PM to Midnight

September 5<sup>th</sup>—September 7<sup>th</sup>—6AM to Midnight

w/o Electricity—September 3<sup>rd</sup> & September 4<sup>th</sup>—5PM to Dusk

September 5<sup>th</sup>—September 7<sup>th</sup>—6AM to Dusk

### **SETUP:**

7AM—September 3, 2009 (Earlier arrivals will **NOT** be permitted to begin setting up)

### **CAMPING:**

Unimproved camping is available behind your booth. There is no charge for one camper, however there IS an electricity charge (if needed).

### **SECURITY:**

A watchman will be in or around the display area during non-display times, however, we do not assume responsibility for damaged or stolen property.

### **NOTE:**

There is **NO** subleasing of footage purchased from the National Sweetcorn Festival.  
**NO** generators are allowed near display area without prior approval.

#### **DISPLAY AREA:**

\$17 per Frontage Foot (Total Distance)

#### **POWER SUPPLY:**

\$25 per Outlet (120 volt, 20 Amp) for five Days

\$50 for One (1) Connection (220 volt, 40 Amp) for Five Days

**NOTE:** Any Breaker over 40 Amp will be charged extra.

### SETUP:

Begins 3PM—Wednesday, September 2, 2009 (Earlier arrivals will **NOT** be permitted to begin setting up)

### DISPLAY TIMES:

September 3<sup>rd</sup> & September 4<sup>th</sup>—5PM to Midnight

September 5<sup>th</sup>—September 7<sup>th</sup>—6AM to Midnight

### PROHIBITED FOOD:

Because of an exclusive contract with the Carnival, you may **NOT** sell the following items: Corn Dogs, Taffy, Carmel Apples, Popcorn or Cotton Candy

### CAMPING:

Unimproved camping is available along the west end of the park. There is no charge for one camper per food booth, however there IS a \$25 charge for one (1) 120 volt electricity charge per camper (if needed).

### SECURITY:

A watchman will be in or around the food area during non-display times, however, we do not assume responsibility for damaged or stolen property.

### NOTE:

There is **NO** subleasing of footage purchased from the National Sweetcorn Festival.
